Dear Mr. Patil

This has reference to your letter, dated 10/08/2017 expressing interest to conduct Bosch Bridge Program in your institute. At the outset, we thank you for your interest in this initiative.

We would like to reiterate the following for the clarity in understanding.
You have agreed to,

1. Provide one classroom with seating capacity of 25 students with requisite furniture and equipment. E.g. Chairs, Projector, White Board, White Board Marker and Computer with internet connection. Bosch will not provide any financial support for either constructing or maintaining infrastructure.
2. Provide one Computer lab with minimum 10 computers in working condition with internet facility at least for one hour daily.
3. Mobilise 25 students per batch as per defined criteria of BRIDGE Program.(drop outs from education system, min. 10th pass ; Age group: 18 years – 25 years)
4. Run the course by charging the fee from the students (maximum up to Rs. 5000/- per student) not depending on any funding from Bosch or any other organization/Government.
5. Appoint BRIDGE trainer at your own costs. The selection of trainer will be in consultation of Bosch representative.
6. No modification of the course module and duration or any training methodology without the prior written permission of Bosch Limited.
7. Provide safety and security to the trainees during class timings.

To run this program successfully in your institution, we would offer following support:

1. Bosch will provide course completion certificate to those students who successfully complete the program as per attendance criteria defined by Bosch and upon their successful passing of the assessments.
2. Bosch has designed exclusive Train the Trainer ("TTT") Program and agrees to provide training to one designated trainer who will conduct BRIDGE program. The cost of training, lodging, boarding and also the "Training The Trainer" fee will be borne by the BRIDGE training partner on actuals. The cost of training fee will be informed by Bosch, subsequently.
3. Bosch will provide Learners' Kit to every registered student. These kits will be given Free to students enrolled in the batches completed on or before 30/06/2018.
4. Bosch will support in providing placement assistance to the students who successfully complete the program, however, selection of students completely depends on student's merit, job selection criteria, and type of job opening. Decision of concerned employer will be final and binding on the job seeker. (No jobs in Bosch or its ancillaries.)

BRIDGE program is to be run by you, without any change in branding/logo on Bosch printed materials like book, uniforms or any other collateral supplied by Bosch.

This offer is valid up to completion of BRIDGE batches on or before 30/06/2018. Based on your center's performance of the batches completed up to 30/06/2018., Bosch will decide on future arrangements, whether to continue BRIDGE program in your center or to discontinue.

Please note that Bosch decision in this regards shall be final and binding.

In order to promote co-operation in areas of mutual interest in Educational Technologies for the benefit of both institutions Rayat Shikshan Sanstha, Satara, one of the leading educational institutions in Asia and Centre for Development of Advanced Computing, Mumbai ("C-DAC, Mumbai") - a Scientific Society of the Department of Electronics and Information Technology (DeitY), Ministry of Communications and Information Technology, Government of India, with its Mumbai center at Gurnohar Cross Road No. 9, Juhu, Mumbai - 400048, Maharashtra, India, herein after individually referred to as Party or collectively as Parties, hereby enter into the following Memorandum Of Understanding ("MoU") dated ___ May 2016:

Article 1. Scope and Objectives: C-DAC, Mumbai will develop and provide the software solutions for Maharashtra State Education Board's Continuous and Comprehensive Evaluation-based Assessment and Monitoring Framework (AMF), Online Labs teacher training, and eBasta teacher training for Schools of Rayat Shikshan Sanstha. AMF includes student registration, teacher registration, assessment creations, marks entry, result processing and reports generations. A detailed scope of work is attached in Appendix A. C-DAC, Mumbai will develop the software in consultation with Rayat Shikshan Sanstha, Satara. Rayat Shikshan Sanstha will provide all the help in gathering of requirements to C-DAC, Mumbai. The software will be provided to Rayat Shikshan Sanstha along with the source code. In addition to providing the software, C-DAC agrees to deploy the software into production and support it for the 2016-2017 and 2017-2018 academic years. Rayat Shikshan Sanstha agrees to provide performance data of the software in production to C-DAC for research purpose use in tuning the software for future.

For online labs and eBasta, the scope covers primarily helping the schools under sansitha use these resources by training their teachers and providing online and email support. No fees is payable to CDAC for the software. Training at approx two teachers per school will also provided free. Please see appendix A for detailed terms and condition for this.

Article 2. Payments: For AMF no payment fees is applicable for the academic years 2016-2017 and 2017-2018.



AND

TATA CONSULTANCY SERVICES LTD., (hereinafter referred to as TCS), wherein Tata Consultancy Services is a public limited company registered under the Companies Act, 1956 having its corporate office at 11th Floor, Air India Building, Nariman Point, Mumbai -400 021, Maharashtra, the OTHER PART.

RAYAT SHIKSHAN SANSTHA and "TCS" are hereinafter collectively referred to as the "Parties" and individually as "Party" as applicable.

1. PURPOSE

The purpose of this MOU is to provide the framework for a partnership arrangement between RAYAT SHIKSHAN SANSTHA and TCS, to provide training services to improve the employability of students graduating from RAYAT SHIKSHAN SANSTHA

Objective: The employability of our graduates continues to remain weak. In the current context, skilling graduates to enhance their employability and enabling them to be effective contributors of nation's growth and development assumes paramount importance. Though the institute help the students to get the knowledge there is a requirement to enhance the skills. Thus, the idea is to start imparting Employability and Skill Development Training to Rayat Shikshan Sanstha's graduate students.

The main objective is to provide 80-100 hours free training so as to groom and hone employability skills of graduates who are unemployed as well as final year graduation students.

Scope: It is intended to provide training to unemployed graduates and final year students of Rayat Shikshan Sanstha.

12. ENTIRE AGREEMENT:

This MOU constitutes the entire understanding between the Parties and supersedes any and all prior understandings and arrangements whether oral or written between the Parties relating to the subject matter hereof.

13. SEVERABILITY:

Any provision of this MOU that is determined to be invalid or unenforceable in any jurisdiction shall be ineffective to the extent of such invalidity or unenforceability in such jurisdiction, without rendering invalid or unenforceable the remaining provisions of this MOU or affecting the validity or enforceability of such provision in any other jurisdiction.

14. AMENDMENTS:

Amendments, modifications or waiver in respect of this MOU will be effective in writing and executed by both the Parties

15. WAIVER:

Any failure by either Party to enforce any provision of this MOU shall not be construed as a waiver of the rights to so enforce such provisions at a later date or upon any subsequent breach.

16. ASSIGNMENT AND SUCCESSION:

7. Validity and Termination of MOU

- 7.1 The MOU shall come into force immediately on signing by both Sides and shall be valid for a period of five years from the date of signing.
- 7.2 However, either Party can terminate the MOU at any time within the period by informing the other Party in writing with a three-month notice.
- 7.3 Any decision to terminate the MOU shall not in any manner affect the on-going cooperation. Any agreement on IPR protection, non-disclosure of information etc. reached between the Parties in the course of validity of this MOU shall continue to be in force and shall remain binding on the Parties.
- 7.4 Unless otherwise indicated by either Party, the tenure shall be automatically renewed for another five-year period at the end of the initial five-year period.
